This Amended Stipulation of Settlement (the "Stipulation") is made and entered into by
 and between Lead Plaintiff and Class Representative Norfolk County Council as Administering
 Authority of the Norfolk Pension Fund ("Norfolk" or "Lead Plaintiff"), on behalf of itself and the
 proposed Class (defined below), on the one hand, and Defendants Apple Inc. ("Apple" or the
 "Company"), Timothy D. Cook, and Luca Maestri (collectively, "Defendants," and together with
 Lead Plaintiff, the "Parties" or the "Settling Parties") on the other hand.

All words or terms used herein that are capitalized shall have the meanings ascribed to
8 those words or terms as set forth herein and in ¶1 hereof entitled "Definitions."

I.

THE LITIGATION

10 On April 16, 2019, the first complaint in this action was filed in the United States District 11 Court for the Northern District of California under the caption City of Roseville Employees' 12 Retirement System v. Apple Inc., No. 4:19-cv-02033. ECF 1. On August 14, 2019, the Court 13 appointed the Employees' Retirement System of the State of Rhode Island ("Rhode Island") as 14 lead plaintiff. ECF 72. On October 15, 2019, Rhode Island filed a Consolidated and Amended 15 Class Action Complaint for Violation of the Federal Securities Laws. ECF 85. On December 16, 16 2019, Defendants moved to dismiss that complaint. ECF 91. On June 2, 2020, the Court issued 17 an Order granting in part and denying in part Defendants' motion to dismiss and ordering the 18 transition of lead plaintiff from Rhode Island to Norfolk. ECF 110. On June 19, 2020, the Court 19 issued an order appointing Norfolk as lead plaintiff and Robbins Geller Rudman & Dowd LLP 20 ("Robbins Geller") as lead counsel. ECF 113. On June 23, 2020, Norfolk filed its Revised 21 Consolidated Class Action Complaint for Violation of the Federal Securities Laws (the 22 "Complaint"). ECF 114. The Complaint alleged, *inter alia*, that on November 1, 2018, Defendants 23 made materially false and misleading statements and omissions about demand for the newly-24 released iPhone and Apple's business in China, in violation of §§10(b) and 20(a) of the Securities 25 Exchange Act of 1934. The Complaint further alleged that the false and misleading statements 26 and omissions caused Apple stock to trade at artificially inflated prices, and that, when the true 27 facts were disclosed, Apple's stock price declined.

Defendants moved to dismiss the Complaint on July 13, 2020. ECF 118. Norfolk opposed
 the motion on July 27, 2020. ECF 120. On November 4, 2020, the Court issued an Order granting
 in part and denying in part Defendants' motion to dismiss. ECF 123.

4 On May 5, 2021, Norfolk filed its motion for class certification. ECF 165. On February 5 4, 2022, the Court issued an Order granting the motion in part, certifying a Class of purchasers or 6 acquirers of Apple common stock, and denying (without prejudice) the motion with respect to the 7 proposed class of options investors. ECF 224. The Court appointed Norfolk as the Class 8 Representative, and Robbins Geller as Class Counsel. On April 15, 2022, Norfolk filed a 9 supplemental motion seeking certification of a class of options investors. ECF 239. On March 10 28, 2023, the Court issued an Order Modifying Class, which granted Norfolk's motion to certify call option buyers and put option sellers as part of the Class. ECF 352. 11

On September 9, 2022, Defendants filed a Motion for Summary Judgment and Motion to
Exclude Expert Testimony. ECF 292, 293. On September 9, 2022, Lead Plaintiff filed an
Omnibus Motion to Exclude Opinion Testimony of Defendants' Proposed Experts. ECF 301. On
June 26, 2023, the Court issued an Order Denying Summary Judgment. ECF 369. On July 17,
2023, the Court issued an Order denying Defendants' Motion to Exclude and granting in part and
denying in part Lead Plaintiff's Motion to Exclude. ECF 384.

On February 27, 2024, the Court issued an Amended Pretrial Scheduling Order setting
deadlines for the parties to exchange and submit witness lists, motions *in limine*, proposed jury
instructions, and other pretrial materials, as well as setting a trial date of September 9, 2024. ECF
420.

- In late 2021, the Parties first engaged the services of the Hon. Layn R. Phillips (Ret.), a nationally recognized mediator, to facilitate settlement negotiations. On January 31, 2022, the Parties attended a mediation session with Judge Phillips held remotely via videoconference. The January 31, 2022 mediation was preceded by the submission of voluminous mediation statements, including exhibits. The mediation did not result in a settlement.
- On May 25, 2022, the Parties attended a second mediation session with Judge Phillips, this
 time in person. The May 25, 2022, mediation was also preceded by the submission of

supplemental mediation statements with additional exhibits and excerpts of deposition testimony
 by each of the Parties. Again the Parties did not reach an agreement at that mediation and litigation
 continued.

4 Following the May 25, 2022 mediation and concurrent with the ongoing litigation, Judge 5 Phillips continued to correspond with the Parties to explore the potential for resolution of the case. On January 10, 2024, the Parties engaged in another in-person mediation session with Judge 6 7 Phillips, but again the Parties were unable to reach a settlement. On February 14, 2024, Judge 8 Phillips issued a mediator's proposal to resolve all claims alleged in the Complaint and on March 9 1, 2024, the Parties accepted the Mediator's proposal. The agreement to accept the mediator's 10 proposal included, among other things, the Settling Parties' agreement to settle and release all claims that were asserted or could have been asserted in the Action in return for a cash payment of 11 \$490,000,000 to be paid by Apple and/or its insurers on behalf of Defendants, for the benefit of 12 13 the Class, subject to the negotiation of the terms of a Stipulation of Settlement and approval by the 14 Court. This Stipulation (together with the Exhibits hereto) reflects the final and binding agreement 15 between the Settling Parties.

II. LEAD PLAINTIFF'S CLAIMS AND BENEFITS OF SETTLEMENT

17 Lead Plaintiff believes that the claims asserted in the Action have merit and that the 18 evidence developed to date supports the claims asserted. However, Lead Plaintiff and Lead 19 Counsel recognize and acknowledge the expense and length of continued proceedings necessary 20 to prosecute the Action through trial (and any possible appeals). Lead Plaintiff and Lead Counsel 21 also have taken into account the uncertainty and the risk of any litigation, especially in complex 22 actions such as the Action, as well as the difficulties and delays inherent in such litigation. Lead 23 Counsel is also mindful of its burden of proof and the possible defenses to the claims alleged in 24 the Action. Based on their evaluation, Lead Plaintiff and Lead Counsel believe that the Settlement 25 set forth in this Stipulation confers a substantial benefit upon, and is in the best interests of, the 26 Class.

1 III. DEFENDANTS' DENIALS OF LIABILITY

Defendants deny each and all of the claims, contentions, and allegations made by Lead Plaintiff in the Action. They have expressly denied and continue to deny that they have violated the federal securities laws or any other laws, or have otherwise misled investors as alleged in the Action. Defendants have denied and continue to deny the allegations that any of the Defendants made any material misstatements or omissions, and that any member of the Class has suffered damages resulting from the conduct alleged in the Action. In addition, Defendants maintain that they have meritorious defenses to the claims alleged in the Action.

9 Nonetheless, Defendants have concluded that after four years of litigation, further litigation
10 will be protracted, overly burdensome, expensive, and distracting. Defendants also have taken
11 into account the uncertainty, risks, and costs inherent in any litigation, especially in complex cases
12 such as this Action. Defendants have, therefore, determined that it is desirable and beneficial to
13 them that the Action be fully, finally, and forever resolved, discharged, and settled in the manner
14 and upon the terms and conditions set forth in this Stipulation.

IV. TERMS OF THE STIPULATION AND AGREEMENT OF SETTLEMENT

16 NOW THEREFORE, without any concession by Lead Plaintiff that the Action lacks merit, 17 and without any concession by Defendants of any liability or wrongdoing or truth as to the 18 allegations of Lead Plaintiff or lack of merit in Defendants' defenses, it is hereby STIPULATED 19 AND AGREED, by and among the Parties to this Stipulation, through their respective attorneys, 20subject to approval by the Court pursuant to Rule 23(e) of the Federal Rules of Civil Procedure, 21 that, in consideration of the benefits flowing to the Parties hereto, all Released Claims (including 22 Unknown Claims) and all Released Defendants' Claims (including Unknown Claims), as against 23 all Released Parties, shall be fully, finally, and forever compromised, settled, released, discharged, 24 and dismissed with prejudice, and without costs (except as provided in the Stipulation), upon and 25 subject to the following terms and conditions:

1. Definitions

As used in this Stipulation, the following terms shall have the meanings set forth below.

28

1.1 "Action" means the civil action captioned *In re Apple Inc. Securities Litigation*,
 2 No. 4:19-cv-02033-YGR, pending in the United States District Court for the Northern District of
 3 California before the Honorable Yvonne Gonzalez Rogers.

- 4 1.2 "Authorized Claimant" means a Class Member whose claim for recovery from the
 5 Settlement has been allowed pursuant to the terms of the Stipulation.
- 6
 1.3 "Claimant" means a person or entity who or which submits a Proof of Claim to the
 7
 8
 Claims Administrator seeking to be eligible to share in the Net Settlement Fund.
- 1.4 "Claims Administrator" means the administrator retained by Lead Counsel, subject
 to the approval of the Court, to provide all notices approved by the Court to potential Class
 Members and to administer the Settlement. Defendants shall have no involvement in the retention
 of any claims administrator (except in connection with the potential retention of an administrator
 for purposes of serving notice pursuant to the Class Action Fairness Act, 28 U.S.C. §1715
 ("CAFA")).
- 15 "Class" or "Class Member" means all Persons that purchased or otherwise acquired 1.5 16 the publicly traded securities of Apple Inc., including purchasers of Apple Inc. call options and 17 sellers of Apple Inc. put options, during the period from November 2, 2018, through January 2, 18 19 2019, inclusive, and who suffered damages by Defendants' alleged violations of \S 10(b) and 20(a) 20 of the Exchange Act. Excluded from the Class are: (i) Apple and the Individual Defendants; 21 (ii) members of the families of each Individual Defendant; (iii) officers and directors of Apple; 22 and (iv) the legal representatives, heirs, successors, or assigns of any such excluded party. Also 23 excluded from the Class is any Person who timely and validly seeks exclusion from the Class. 24
- 1.6 "Class Period" means the period from November 2, 2018, through January 2, 2019,
 inclusive.
 - 1.7 "Defendants" means Apple Inc., Timothy D. Cook, and Luca Maestri.

1.8 "Defendants' Counsel" means Orrick, Herrington & Sutcliffe LLP and Paul, Weiss, 1 2 Rifkind, Wharton & Garrison LLP. 3 1.9 "Effective Date" means the date upon which the Settlement shall have become 4 effective, as set forth in ¶7.1, below. 5 1.10 "Escrow Account" means the separate escrow account designated and controlled 6 by Lead Counsel into which the Settlement Amount will be deposited for the benefit of the Class. 7 1.11 "Escrow Agent" means Robbins Geller Rudman & Dowd LLP and its successor(s). 8 9 1.12 "Fee and Expense Application" means Lead Counsel's application for an award of 10 attorneys' fees and litigation expenses. 11 "Final" means, with respect to any order of the Court, including, without limitation, 1.13 12 the Judgment, that such order represents a final and binding determination of all issues within its 13 scope and is not subject to further review on appeal or otherwise. Without limitation, an order 14 becomes "Final" when: (i) no appeal has been filed and the prescribed time for commencing any 15 16 appeal has expired; or (ii) an appeal has been filed and either (a) the appeal has been dismissed 17 and the prescribed time, if any, for commencing any further appeal has expired, or (b) the order 18 has been affirmed in all material respects and the prescribed time, if any, for commencing any 19 further appeal has expired. For purposes of this definition of "Final," an "appeal" includes any 20motion to alter or amend under Rule 52(b) or Rule 59(e) of the Federal Rules of Civil Procedure, 21 any appeal as of right, discretionary appeal, interlocutory appeal, petition for writ of certiorari, or 22 other proceeding involving writs of certiorari or other proceeding of like kind. However, any 23 appeal or proceeding seeking subsequent judicial review pertaining solely to the Plan of 24 25 Allocation, or to the Court's award of attorneys' fees or expenses, shall not in any way delay or 26 affect the time set forth above for the Judgment to become Final or otherwise preclude the 27 Judgment from becoming Final. 28

 2 Settlement and Providing for Notice, which shall be substantially in the form attached hereto as
 3 Exhibit A.

1.25 "Proof of Claim" means the form, which shall be substantially in the form attached
hereto as Exhibit A-2, which a Claimant must complete and submit to the Claims Administrator
in order to be eligible to share in a distribution of the Net Settlement Fund, provided, however,
that such form has received the approval of the Court.

"Released Claims" means any and all claims, demands, losses, rights, and causes 1.27 21 of action of every nature and description, including both known and Unknown Claims (as defined 22 below), whether arising under federal, state, common, or foreign law, that Lead Plaintiff or any 23 other member of the Class (i) asserted in any complaint filed in the Action, or could have asserted 24 25 or could in the future assert in any court or forum that arise out of any of the allegations, 26 transactions, facts, matters or occurrences, representations or omissions involved, set forth, or 27 referred to in any complaint filed in the Action and (ii) that concern in any way, directly or 28

indirectly, the purchase, acquisition, holding (by those who purchased or otherwise acquired Apple
securities during the Class Period), sale or disposition of Apple securities during the Class Period.
"Released Claims" does not include claims arising from the enforcement of the Settlement,
derivative claims, or any claims of any Person that submits a request for exclusion from the Class
that is accepted by the Court.

Released Plaintiff Parties does not include any Person who timely and validly seeks 27 exclusion from the Class.

With respect to any 17 and all Released Claims and Released Defendants' Claims, the Released Parties stipulate and agree 18 that, upon the Effective Date, Lead Plaintiff and Class Members (as regards the Released Claims) 19 and Defendants (as regards the Released Defendants' Claims) shall expressly waive and relinquish, 20and each Class Member shall be deemed to have and by operation of law and of the Judgment shall 21 have, expressly waived and relinquished, to the fullest extent permitted by law, any and all 22 provisions, rights, and benefits conferred by California Civil Code §1542, or any law of any state 23 or territory of the United States, or principle of common law or of international or foreign law, 24 25 which is similar, comparable, or equivalent to Cal. Civ. Code §1542, which provides: 26 A general release does not extend to claims that the creditor or
 - A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

1 The Released Parties may hereafter discover facts in addition to or different from those that he, 2 she, they, or it now knows or believes to be true with respect to the subject matter of Released 3 Claims or Released Defendants' Claims, but they stipulate and agree that, upon the Effective Date 4 of the Settlement, the Released Parties shall expressly waive and by operation of the Judgment 5 shall have, fully, finally, and forever settled and released, any and all Released Claims or Released Defendants' Claims, known or unknown, suspected or unsuspected, contingent or non-contingent, 6 7 whether or not concealed or hidden, that now exist, or heretofore have existed, upon any theory of 8 law or equity now existing or coming into existence in the future, including, but not limited to, 9 conduct that is negligent, intentional, with or without malice, or a breach of fiduciary duty, law or 10 rule, without regard to the subsequent discovery or existence of such different or additional facts. The Parties acknowledge, and each of the Class Members shall be deemed by operation of law to 11 12 have acknowledged, that the foregoing waiver was separately bargained for and a key element of 13 the Settlement.

The Settlement

2.

a. The Settlement Fund

2.1 In full settlement of the Released Claims, the Settlement Amount shall be paid as follows:

(a) Apple shall pay \$120,000,000 into the Escrow Account no later than March
14, 2024; and

(b) Defendants shall pay or cause to be paid \$370,000,000 into the Escrow
 Account within fifteen (15) calendar days after execution of the Preliminary Approval Order.

The Settlement Amount, together with any interest and income earned thereon once transferred, shall constitute the Settlement Fund.

b. The Escrow Agent

9 2.5 The Escrow Agent shall invest the Settlement Fund deposited pursuant to ¶2.1 10 hereof in instruments backed by the full faith and credit of the United States Government or an 11 agency thereof, or in money funds holding only instruments backed by the full faith and credit of 12 the United States Government or fully insured by the United States government or an agency 13 thereof, and shall reinvest the proceeds of these instruments as they mature in similar instruments 14 at their then-current market rates. All costs and risks related to the investment of the Settlement 15 Fund in accordance with the guidelines set forth in this paragraph shall be borne by the Settlement 16 17 Fund.

18 2.6 The Escrow Agent shall not disburse the Settlement Fund except: (a) as provided
 19 in the Stipulation; (b) by an order of the Court; or (c) with the written agreement of counsel for the
 20 Parties.

2.7 Subject to further order(s) and/or directions as may be made by the Court, or as
provided in the Stipulation, the Escrow Agent is authorized to execute such transactions as are
provided for under the terms of the Stipulation. The Released Parties shall have no responsibility
for, interest in, or liability whatsoever with respect to, the actions of the Escrow Agent, or any
transaction executed by the Escrow Agent (unless acting as the Escrow Agent).

2.8 All funds held by the Escrow Agent shall be deemed and considered to be in
 custodia legis of the Court, and shall remain subject to the jurisdiction of the Court, until such time
 as such funds shall be distributed pursuant to the Stipulation and/or further order(s) of the Court.

2.9 Notwithstanding that the Effective Date has not occurred, Lead Counsel may pay
from the Settlement Fund the reasonable costs and expenses actually incurred in connection with
providing notice to the Class, locating Class Members, soliciting claims, assisting with the
submission of claims, processing Proofs of Claim, administering and preparing for distributing the
Net Settlement Fund to Authorized Claimants, and paying escrow fees and costs, if any ("Notice
and Administration Expenses").

c. Taxes

12 2.10 The Parties agree to treat the Settlement Fund as being at all times a (a) 13 "Qualified Settlement Fund" within the meaning of Treasury Regulation §1.468B-1. In addition, 14 the Escrow Agent shall timely make such elections as necessary or advisable to carry out the 15 provisions of this ¶2.9, including the "relation-back election" (as defined in Treasury Regulation 16 17 §1.468B-1) back to the earliest permitted date. Such elections shall be made in compliance with 18 the procedures and requirements contained in such regulations. It shall be the responsibility of the 19 Escrow Agent to timely and properly prepare and deliver the necessary documentation for 20signature by all necessary parties, and thereafter to cause the appropriate filing to occur.

(b) For the purpose of §468B of the Internal Revenue Code of 1986, as
amended, and the regulations promulgated thereunder, the "administrator" shall be the Escrow
Agent. The Escrow Agent shall timely and properly file all informational and other tax returns
necessary or advisable with respect to the Settlement Fund (including, without limitation, the
returns described in Treasury Regulation §1.468B-2(k)). Such returns (as well as the election
described in ¶2.9(a) hereof) shall be consistent with this ¶2.9 and in all events shall reflect that all

Further, Taxes and Tax Expenses shall be treated as, and considered to be, 15 a cost of administration of the Settlement Fund and shall be timely paid by the Escrow Agent out 16 17 of the Settlement Fund without prior order from the Court, and the Escrow Agent shall be obligated 18 (notwithstanding anything herein to the contrary) to withhold from distribution to Authorized 19 Claimants any funds necessary to pay such amounts, including the establishment of adequate 20reserves for any Taxes and Tax Expenses (as well as any amounts that may be required to be 21 withheld under Treasury Regulation \$1.468B-2(1)(2); neither the Released Defendant Parties nor 22 their counsel are responsible nor shall they have any liability therefor. d. Termination of Settlement

2 2.11 In the event the Settlement is not approved or is terminated, canceled, or fails to 3 become effective for any reason, including, without limitation, in the event the Stipulation is not 4 approved or Judgment is reversed or vacated following any appeal taken therefrom, the Settlement 5 Fund (including accrued interest), less expenses actually incurred or due and owing for Notice and 6 Administration Expenses, Taxes or Tax Expenses pursuant to ¶2.8 or 2.9, shall be refunded 7 pursuant to ¶¶6.2 and 7.4 and written instructions from Defendants' Counsel to any party, parties 8 9 or insurers that paid the Settlement Amount within seven (7) calendar days from the date of the 10 notice from Defendants' Counsel pursuant to ¶7.4.

Preliminary Approval Order and Settlement Hearing

12 3.1 Not later than March 15, 2024, Lead Counsel shall submit this Stipulation together 13 with its exhibits (the "Exhibits") to the Court and shall apply for entry of an order (the "Preliminary 14 Approval Order"), requesting, inter alia, the preliminary approval of the Settlement set forth in 15 the Stipulation, and approval for the dissemination of the Notice, Proof of Claim, and the Summary 16 Notice, in the forms of Exhibits A-1 through A-3, respectively, attached hereto. The Notice shall 17 18 contain the general terms of the Settlement set forth in the Stipulation, the proposed Plan of 19 Allocation, the general terms of the Fee and Expense Application, and the date of the Settlement 20Hearing.

- 3.2 At the same time that Lead Counsel applies for entry of the Preliminary Approval
 Order, Lead Counsel shall request that the Court vacate all deadlines in the Action except for
 proceedings related to the Settlement.
- 3.3 Lead Counsel shall request that, after notice is given to the Class, the Court hold
 the Settlement Hearing and approve the Settlement of the Action as set forth herein. At or after

the Settlement Hearing, Lead Counsel also shall request that the Court approve the proposed Plan
 of Allocation and the Fee and Expense Application.

4. Releases

4 4.1 Upon the Effective Date, Lead Plaintiff and each of the Class Members (who have 5 not validly opted out of the Class), on behalf of themselves, and their respective former and present 6 officers, directors, employees, agents, affiliates, parents, subsidiaries, insurers, reinsurers, heirs, 7 executors, administrators, predecessors, successors, and assigns in their capacities as such, shall 8 9 be deemed to have, and by operation of law and of the Judgment shall have, fully, finally, and 10 forever released, relinquished, waived, and discharged against the Released Defendant Parties 11 (whether or not such Class Members execute and deliver the Proof of Claim) any and all Released 12 Claims (including, without limitation, Unknown Claims).

4.2 Upon the Effective Date, Lead Plaintiff and each of the Class Members (who have 14 not validly opted out of the Class), on behalf of themselves, and their respective former and present 15 officers, directors, employees, agents, affiliates, parents, subsidiaries, insurers, reinsurers, heirs, 16 17 executors, administrators, predecessors, successors, and assigns in their capacities as such, shall 18 be permanently barred and enjoined from the institution, maintenance, prosecution, or enforcement 19 against any Released Defendant Party, in any state or federal court or arbitral forum, or in the court 20of any foreign jurisdiction, of any and all Released Claims (including, without limitation, 21 Unknown Claims). The Court shall retain exclusive jurisdiction to interpret and enforce the 22 permanent injunction described in this paragraph. 23

4.3 The Proof of Claim to be executed by Class Members shall release all Released
 Claims against the Released Defendant Parties and shall be substantially in the form contained in
 Exhibit A-2 incorporated herein; provided, however, that the failure of a Class Member to submit
 such Proof of Claim shall have no effect on the provisions of the foregoing ¶4.1 and 4.2, inclusive,

1 which shall remain in full force and effect as to each of the Class Members (who have not validly 2 opted out of the Class) irrespective of any lack of submission of a Proof of Claim.

- 3 4.4 Upon the Effective Date, each of the Released Defendant Parties, on behalf of 4 themselves, and their respective former and present officers, directors, employees, agents, 5 affiliates, parents, subsidiaries, insurers, reinsurers, heirs, executors, administrators, predecessors, 6 successors, and assigns in their capacities as such, shall be deemed to have, and by operation of 7 the Judgment shall have, fully, finally, and forever released, relinquished, and discharged the 8 9 Released Plaintiff Parties, including Plaintiffs' Counsel, from all Released Defendants' Claims 10 (including, without limitation, Unknown Claims).

Administration and Calculation of Claims, Final Awards, and Supervision and Distribution of the Settlement Fund

- 13 5.1 The Claims Administrator, subject to such supervision and direction of the Court 14 as may be necessary or as circumstances may require, shall provide notice of the Settlement to the 15 Class, shall administer and calculate the claims submitted by Class Members, and shall oversee 16 distribution of the Net Settlement Fund to Authorized Claimants.
- 17 5.2 Within five (5) business days after the Court enters the Preliminary Approval Order, 18 Apple shall provide Lead Counsel or the Claims Administrator, without any charge to Lead 19 Plaintiff, the Settlement Fund, Lead Counsel, the Claims Administrator, to the extent available to 20 21 Apple, record shareholder lists, as appropriate for providing notice to the Class. The Parties shall 22 determine an appropriate electronic format for provision of this information.
- 23 5.3 In accordance with the schedule set forth in the Preliminary Approval Order, Lead 24 Counsel will cause the Summary Notice, substantially in the form of Exhibit A-3 incorporated 25 herein, to be emailed or mailed where email addresses are not available, by the Claims 26 Administrator to all shareholders of record, or nominees. 5.4 Not later than seven (7) calendar days prior to the Settlement Hearing, Lead
7 Counsel shall serve on Defendants' Counsel and file with the Court proof, by affidavit or
8 declaration, of such emailing, mailing, and publication.

- 5.6 Each Person claiming to be an Authorized Claimant shall be required to submit to

 days after the Notice Date (as defined in the Preliminary Order), or such other time as may be set

1 by the Court (the "Bar Date"), signed under penalty of perjury and supported by such documents 2 as are specified in the Proof of Claim and as are reasonably available to such Person.¹

5.7 Except as otherwise ordered by the Court, all Class Members who fail to submit a 4 Proof of Claim by the Bar Date, or such other period as may be ordered by the Court, or who 5 submit a Proof of Claim that is rejected, shall be forever barred from receiving any payments 6 pursuant to the Stipulation and the Settlement set forth herein, but will in all other respects be 7 subject to and bound by the provisions of the Stipulation, the releases contained herein, and the 8 9 Judgment. Notwithstanding the foregoing, Lead Counsel shall have the discretion (but not the 10 obligation) to accept late-submitted claims for processing so long as the distribution of the Net 11 Settlement Fund to Authorized Claimants is not materially delayed thereby.

5.8 Each Proof of Claim shall be submitted to and reviewed by the Claims 13 Administrator, under the supervision of Lead Counsel, who shall determine, in accordance with 14 this Stipulation and the approved Plan of Allocation, the extent, if any, to which each claim shall 15 16 be allowed, subject to review by the Court pursuant to ¶5.10 below.

17 5.9 Proof of Claim forms that do not meet the submission requirements may be 18 rejected. Prior to rejecting a Proof of Claim in whole or in part, the Claims Administrator shall 19 communicate with the Claimant in writing to give the Claimant the chance to remedy any curable 20deficiencies in the Proof of Claim submitted. The Claims Administrator, under the supervision of 21 Lead Counsel, shall notify, in a timely fashion and in writing, all Claimants whose claims the 22 Claims Administrator proposes to reject in whole or in part for curable deficiencies, setting forth 23 the reasons therefor, and shall indicate in such notice that the Claimant whose claim is to be 24 25

1 rejected has the right to a review by the Court if the Claimant so desires and complies with the 2 requirements of ¶5.10 below.

If any Claimant whose Proof of Claim has been rejected in whole or in part desires 5.10 4 to contest such rejection, the Claimant must, within twenty (20) days after the date of mailing of 5 the notice required in ¶5.9 above, serve upon the Claims Administrator a notice and statement of 6 reasons indicating the Claimant's grounds for contesting the rejection along with any supporting 7 documentation, and requesting a review thereof by the Court. 5.13 The Released Defendant Parties shall have no responsibility for, interest in, or
liability whatsoever with respect to the processing, review, determination or calculation of any
claims, the distribution of the Net Settlement Fund, the Plan of Allocation, the payment or
withholding of Taxes, or any losses incurred in connection therewith.

5.14 Defendants shall take no position with respect to the Plan of Allocation or any other
 7 such plan as may be approved by the Court.

5.15 It is understood and agreed by the Settling Parties that any proposed Plan of 8 9 Allocation of the Net Settlement Fund, including, but not limited to, any adjustments to an 10 Authorized Claimant's claim set forth therein, is not a part of the Stipulation and is to be considered 11 by the Court separately from the Court's consideration of the fairness, reasonableness, and 12 adequacy of the Settlement set forth in the Stipulation, and any order or proceeding relating to the 13 Plan of Allocation shall not operate to terminate or cancel the Stipulation or affect the finality of 14 the Court's Judgment approving the Stipulation and the Settlement set forth therein, or any other 15 16 orders entered pursuant to the Stipulation. Class Members and Defendants shall be bound by the 17 terms of this Stipulation, irrespective of whether the Court disapproves or modifies the Plan of 18 Allocation.

6. Lead Counsel's Attorneys' Fees and Expenses

6.1 Lead Counsel may submit an application or applications (the "Fee and Expense
Application") for: (a) an award of attorneys' fees; (b) expenses or charges incurred in connection
with prosecuting the Action; plus (c) any interest on such attorneys' fees and expenses at the same

rate and for the same periods as earned by the Settlement Fund (until paid) as may be awarded by
the Court. Any and all such fees, expenses, and costs awarded by the Court shall be payable solely
out of the Settlement Fund. An application for fees and expenses may also include an amount to
one or more of the Representative Parties pursuant to 15 U.S.C. §78u-4(a)(4). Defendants shall
take no position on the Fee and Expense Application.

6

6.2 The attorneys' fees and expenses, as awarded by the Court, shall be paid to Lead 7 Counsel from the Settlement Fund, as ordered, immediately upon entry of the Court's order 8 9 awarding such fees and expenses. This provision shall apply notwithstanding timely objection to, 10 potential for appeal from, or collateral attack on, the Settlement or the award of fees and expenses. 11 Any such awards shall be paid solely by the Settlement Fund. In the event that the Judgment or 12 the order awarding such fees and expenses paid to Lead Counsel pursuant to ¶6.1 and this ¶6.2 is 13 reversed or modified, or if the Settlement is cancelled or terminated for any reason, then Lead 14 Counsel shall, in an amount consistent with such reversal, modification, termination or 15 16 cancellation, refund such fees or expenses to the Settlement Fund pursuant to ¶2.10, plus the 17 interest earned thereon, within ten (10) business days from receiving notice from Defendants' 18 Counsel or from a court of competent jurisdiction. Lead Counsel, as a condition of receiving such 19 fees or expenses on behalf of itself and each partner and/or shareholder of it, agrees that it and its 20partners and/or shareholders are subject to the jurisdiction of the Court for the purpose of enforcing 21 the provisions of this paragraph. 22

6.3 The procedure for and the allowance or disallowance by the Court of the Fee and
Expense Application, or award to the Representative Parties, with all amounts to be paid out of the
Settlement Fund, are not part of the Settlement set forth in the Stipulation, and any order or
proceeding relating to the Fee and Expense Application, or any appeal from any order relating
thereto or reversal or modification thereof, shall not operate to terminate or cancel the Stipulation,

Miscellaneous Provisions

8.1 The Parties (a) acknowledge that it is their intent to consummate this Stipulation;
and (b) agree to cooperate to the extent reasonably necessary to effectuate and implement all terms
and conditions of the Stipulation and to exercise their best efforts to accomplish the foregoing
terms and conditions of the Stipulation expeditiously.

18 8.2 The Parties intend this Settlement to be a final and complete resolution of all 19 disputes between them with respect to the Action. The Settlement shall not be deemed an 20admission by any Party or any of the Released Parties as to the merits of any claim or defense. 21 The Parties and their counsel agree that they shall not assert any claims of any violation of Rule 22 11 of the Federal Rules of Civil Procedure relating to the institution, prosecution, defense, or 23 settlement of the Action, and the Judgment shall contain a finding that all Parties and their counsel 24 25 complied with the requirements of Rule 11 with respect to the institution, prosecution, defense, 26 and resolution of the Action. 8.3 Neither the Stipulation nor the Settlement contained herein, nor any act performed 7 or document executed pursuant to or in furtherance of the Stipulation or the Settlement: (a) is or 8 9 may be deemed to be or may be used as an admission of, or evidence of, the validity of any 10 Released Claim, or of any wrongdoing or liability of the Released Defendant Parties; or (b) is or 11 may be deemed to be or may be used as an admission of, or evidence of, any fault or omission of 12 any of the Released Defendant Parties; or (c) is or may be deemed to be or may be used as an 13 admission or evidence that any claims asserted by Lead Plaintiff were not valid or that the amount 14 recoverable was not greater than the Settlement Amount, in any civil, criminal, or administrative 15 proceeding in any court, administrative agency, or other tribunal.  Stipulation is consummated, or the Effective Date occurs, the Parties and their counsel shall keep
 all negotiations, discussions, acts performed, agreements, drafts, documents signed and
 proceedings in connection with the Stipulation confidential.
- 8.5 All agreements made and orders entered during the course of the Action relating to
 the confidentiality of documents and information shall survive this Stipulation.

8.6 All of the Exhibits to the Stipulation are material and integral parts hereof and are

and memorialized in such documents. Except as otherwise provided herein each Party shall bear
its own costs.

- 18 8.10 The Settlement is not conditioned upon the settlement or approval of settlement of
 19 any other lawsuits. Nor shall the Settlement be conditional upon the obtaining of any judicial
 20 approval of any releases between or among Defendants and/or any third parties.
- 8.11 This Stipulation shall be construed and interpreted to effectuate the intent of the
 Parties, which is to resolve completely those claims and disputes, including in the Action, and as

- 8. No later than seven (7) calendar days after the Notice Date, the Claims
 Administrator shall cause the Summary Notice to be published once in the national edition of *The Wall Street Journal* and once over a national newswire service.

9. At least seven (7) calendar days prior to the Settlement Hearing, Lead Counsel shall
serve on Defendants' Counsel and file with the Court proof, by affidavit or declaration, of such
emailing, mailing, and publication.

10. 1 Nominees who purchased or otherwise acquired Apple publicly traded securities 2 for the beneficial ownership of Class Members during the Class Period shall: (a) within seven (7) 3 calendar days of receipt of the Summary Notice request from the Claims Administrator sufficient 4 copies of the Summary Notice to forward to all such beneficial owners and within seven (7) 5 calendar days of receipt of the Summary Notice forward it to all such beneficial owners; or (b) within seven (7) calendar days of receipt of the Summary Notice, send a list of the names and 6 7 email addresses or physical addresses where an email address is unavailable, of all such beneficial 8 owners to the Claims Administrator in which event the Claims Administrator shall promptly email 9 or mail the Summary Notice to such beneficial owners. Lead Counsel shall, if requested, reimburse 10 banks, brokerage houses, or other nominees solely for their reasonable out-of-pocket expenses incurred in providing notice to beneficial owners who are Class Members out of the Settlement 11 Fund, which expenses would not have been incurred except for the sending of such notice, subject 12 13 to further order of this Court with respect to any dispute concerning such compensation.

14 11. As provided in ¶2.3 of the Stipulation, Apple shall be responsible for the provision
15 of notice pursuant to the Class Action Fairness Act, 28 U.S.C. §1715 ("CAFA"), and shall bear all
16 costs and expenses of providing such notice.

17 12. The Court finds that the form and content of the notice program described herein 18 and the methods set forth herein, for notifying the Class of the Settlement and its terms and 19 conditions, the Fee and Expense Application, and the Plan of Allocation meet the requirements of 20 Rule 23 of the Federal Rules of Civil Procedure, the Private Securities Litigation Reform Act of 21 1995, and due process, constitute the best notice practicable under the circumstances, and shall 22 constitute due and sufficient notice to all Persons entitled thereto.

- 13. In order to be entitled to participate in the recovery from the Settlement Fund after
 the Effective Date, each Class Member shall take the following action and be subject to the
 following conditions:
- (a) A properly completed and executed Proof of Claim must be submitted to
 the Claims Administrator, either by mail or electronically as described in the Notice and Proof of
 Claim, and received by mail or electronically no later than one hundred (100) calendar days from
 [PROPOSED] ORDER PRELIMINARILY APPROVING SETTLEMENT AND PROVIDING

4 (b) The Proof of Claim submitted by each Class Member must satisfy the 5 following conditions: (i) it must be properly filled out, signed, and submitted in a timely manner in accordance with the provisions of the preceding subparagraph; (ii) it must be accompanied by 6 7 adequate supporting documentation for the transactions and holdings reported therein, in the form 8 of broker confirmation slips, broker account statements, an authorized statement from the broker 9 containing the transactional and holding information found in a broker confirmation slip, or such 10 other documentation as is deemed adequate by the Claims Administrator or Lead Counsel; (iii) if the person executing the Proof of Claim is acting in a representative capacity, a certification of his, 11 12 her, its, or their current authority to act on behalf of the Class Member must be provided with the 13 Proof of Claim; and (iv) the Proof of Claim must be complete and contain no material deletions or modifications of any of the printed matter contained therein and must be signed under penalty of 14 15 perjury.

16 (c) Claims that do not meet the submission requirements may be rejected. Once 17 the Claims Administrator has considered a timely submitted Proof of Claim, it shall determine 18 whether such claim is valid, deficient, or rejected. For each claim determined to be either deficient 19 or rejected, the Claims Administrator shall send a deficiency letter or rejection letter as appropriate, 20 describing the basis on which the claim was so determined and shall indicate in such notice that 21 the Claimant whose claim is to be rejected has the right to review by the Court if the Claimant so 22 desires. Persons who timely submit a Proof of Claim that is deficient or otherwise rejected shall 23 be afforded a reasonable time (at least twenty (20) calendar days) to cure such deficiency if it shall 24 appear that such deficiency may be cured.

(d) For the filing of and all determinations concerning their Proof of Claim, each Class Member shall submit to the jurisdiction of the Court.

Any Class Member who does not submit a valid and timely Proof of Claim within the time provided, or whose claim is not otherwise approved by the Court: (a) shall be deemed to 4 5 have waived his, her, or its right to share in the Net Settlement Fund; (b) shall be forever barred from sharing in any distribution of the proceeds of the Net Settlement Fund; (c) shall in all other 6 7 respects be subject to and bound by the provisions of the Stipulation and all proceedings, 8 determinations, orders, and judgments in the Action relating thereto, including without limitation, 9 the Judgment, and the Released Claims provided for therein, whether favorable or unfavorable to 10 the Class; and (d) shall be barred from commencing, maintaining, or prosecuting any Released Claims against each and all of the Released Defendant Parties, as more fully described in the 11 12 Stipulation and Notice. Notwithstanding the foregoing, Lead Counsel shall have the discretion 13 (but not an obligation) to accept late-submitted claims for processing by the Claims Administrator so long as distribution of the Net Settlement Fund to Authorized Claimants is not materially 14 15 delayed thereby, but will bear no liability for failing to accept such late claims.

- 16 15. Any Class Member may enter an appearance in the Action, at their own expense,
 17 individually or through counsel of their own choice. If they do not enter an appearance, they will
 18 be represented by Lead Counsel.
- 19 16. All Class Members shall be bound by all determinations and judgments in this Action, whether favorable or unfavorable, unless such persons request to be excluded, or "opt out," 20 21 from the Class. A Class Member wishing to be excluded from the Class must submit to the Claims 22 Administrator a request for exclusion ("Request for Exclusion"), by first-class mail such that it is 23 postmarked or received no later than thirty (30) calendar days prior to the Settlement Hearing, or 24 , 2024, to the address listed in the Notice and Settlement Website. A Request for Exclusion shall not be effective unless it 3 provides all the required information and is received within the time stated above, or is otherwise 4 accepted by the Court. All Persons who submit valid and timely Requests for Exclusion in the 5 manner set forth in this paragraph shall have no rights under the Stipulation, shall not share in the distribution of the Net Settlement Fund, and shall not be bound by the Stipulation or any Final 6 7 judgment. Unless otherwise ordered by the Court, any Class Member who does not submit a valid 8 and timely written Request for Exclusion as provided by this paragraph shall be bound by the 9 Stipulation.

17. The Claims Administrator, Lead Counsel, or other Person designated to receive
exclusion requests shall cause to be provided to Defendants' Counsel copies of all Requests for
Exclusion by email, whether timely and valid or not, within three (3) business days of receipt
thereof and in any event no later than at least twenty-seven (27) calendar days before the Settlement
Hearing.

15 18. The Court will consider comments or objections to the Settlement, the Plan of 16 Allocation, or Lead Counsel's Fee and Expense Application, only if such comments or objections 17 and any supporting papers are submitted to the Court either by mailing them to the Clerk of the 18 Court, United States District Court for the Northern District of California, 1301 Clay Street, 19 Oakland, CA 94612, or by filing them in person at any location of the United States District Court 20 for the Northern District of California. Such comments or objections must be filed or postmarked 21 or received at least thirty (30) calendar days prior to the Settlement Hearing, or , 2024. 22 Attendance at the Settlement Hearing is not necessary but any Person wishing to be heard orally 23 in opposition to the Settlement, the Plan of Allocation, or the Fee and Expense Application is 24 required to indicate in their written objection whether they intend to appear at the Settlement 25 Hearing. 19. Any Class Member who does not make his, her, their, or its objection in the manner
provided shall be deemed to have waived such objection and shall forever be foreclosed from
making any objection to the fairness or adequacy of the Settlement as set forth in the Stipulation,
to the Plan of Allocation, or to the award of attorneys' fees and expenses to Lead Counsel unless
otherwise ordered by the Court. Class Members do not need to appear at the Settlement Hearing
or take any other action to indicate their approval.

20. All funds held by the Escrow Agent shall be deemed and considered to be in *custodia legis* of the Court, and shall remain subject to the jurisdiction of the Court, until such time
as such funds shall be distributed pursuant to the Stipulation and/or further order(s) of the Court.

16 21. All opening briefs and supporting documents in support of the Settlement, the Plan
17 of Allocation, and/or any Fee and Expense Application by Lead Counsel, including an award to
18 Representative Parties pursuant to 15 U.S.C. §78u-4(a)(4), shall be filed and served no later than
19 sixty-five (65) calendar days before the Settlement Hearing, or ______, 2024. Replies to any
20 objections shall be filed and served at least fourteen (14) calendar days prior to the Settlement
21 Hearing, or ______, 2024.

22 22. The Released Defendant Parties shall have no responsibility for the Plan of 23 Allocation or any Fee and Expense Application submitted by Lead Counsel, and such matters will 24 be considered separately from the fairness, reasonableness, and adequacy of the Settlement. Any 25 order or proceeding relating to the Plan of Allocation or any Fee or Expense Application, or any appeal from any order relating thereto or reversal or modification thereof, shall not operate to 26 27 terminate or cancel the Stipulation, or affect or delay the finality of the Judgment approving the 28 Stipulation and the settlement of the Action. In the event 4 5 the Court does not approve the Settlement, or the Settlement otherwise fails to become effective, neither Plaintiffs' Counsel, the Class, nor the Claims Administrator shall have any obligation to 6 7 repay any amounts actually and properly incurred or disbursed pursuant to ¶¶2.8 or 2.9 of the 8 Stipulation.

9 25. Neither the Stipulation nor the Settlement contained therein, nor any act performed 10 or document executed pursuant to or in furtherance of the Stipulation or the Settlement: (a) is or may be deemed to be or may be used as an admission of, or evidence of, the validity of any 11 Released Claim, or of any wrongdoing or liability of the Released Defendant Parties; or (b) is or 12 13 may be deemed to be or may be used as an admission of, or evidence of, any fault or omission of 14 any of the Released Defendant Parties; or (c) is or may be deemed to be or may be used as an 15 admission or evidence that any claims asserted by Lead Plaintiff were not valid or that the amount 16 recoverable was not greater than the Settlement Amount, in any civil, criminal, or administrative 17 proceeding in any court, administrative agency, or other tribunal.

18 26. If the Stipulation and the Settlement set forth therein is not approved by the Court 19 or the Settlement set forth in the Stipulation is terminated or fails to become effective in accordance 20 with its terms, the Stipulation and Settlement and all proceedings had in connection therewith shall 21 be without prejudice to the rights of the Settling Parties. In such event, any Judgment or order 22 entered by the Court in accordance with the terms of the Stipulation shall be treated as vacated, 23 nunc pro tunc, and the Settling Parties shall revert to their respective positions in the Action as of 24 March 5, 2024, as provided for, and subjection to the exceptions contained in, ¶7.5 of the 25 Stipulation.

26 27. All proceedings in the Action are stayed until further order of this Court, except as
27 may be necessary to implement the Settlement or comply with the terms of the Stipulation.

Statement of Attorneys' Fees and Expenses Sought

Since the Action's inception, Lead Counsel has expended considerable time and effort in 5 the prosecution of this Action on a wholly contingent basis and has advanced the expenses of the Action in the expectation that if it was successful in obtaining a recovery for the Class, it would 6 be paid from such recovery. Lead Counsel will apply to the Court for an award of attorneys' fees not to exceed twenty-five percent (25%) of the Settlement Amount, plus expenses not to exceed 7 \$3 million, plus interest earned thereon. In addition, one or more of the Representative Parties may request an award in connection with their representation of the Class. 16 **Reasons for the Settlement**

17 Lead Plaintiff's principal reason for entering into the Settlement is the substantial benefit to the Class now, without further risk or the delays inherent in continuation of the Action. The 18 cash benefit under the Settlement must be considered against the significant risk that a smaller recovery – or, indeed, no recovery at all – might be achieved after contested motions, trial, and 19 likely appeals, a process that could last several years into the future. For the Defendants, who have denied and continue to deny all allegations of liability, fault, or wrongdoing whatsoever, the 20 principal reason for entering into the Settlement is to eliminate the uncertainty, risk, costs, and burdens inherent in any legal action, especially in complex cases such as this Action. Defendants 21 have concluded that after four years of litigation, further litigation of this Action will be protracted, overly burdensome, expensive, and distracting. 22

The Court in charge of the Action is the United States District Court for the Northern District of California, and the case is known as *In re Apple Inc. Securities Litigation*, No. 4:19-cv-02033-YGR. The case has been assigned to the Honorable Yvonne Gonzalez Rogers. The entity representing the Class, Norfolk County Council as Administering Authority of the Norfolk Pension Fund ("Norfolk"), is the Court-appointed Lead Plaintiff. Apple and the individuals the Lead Plaintiff sued and who have now settled are called the Defendants.

2. What is this lawsuit about?

7 On April 16, 2019, the first complaint in this action was filed in the United States District Court for the Northern District of California under the caption *City of Roseville Employees*' 8 Retirement System v. Apple Inc., No. 4:19-cv-02033. ECF 1. On August 14, 2019, the Court appointed the Employees' Retirement System of the State of Rhode Island ("Rhode Island") as Q lead plaintiff. ECF 72. On October 15, 2019, Rhode Island filed a Consolidated and Amended Class Action Complaint for Violation of the Federal Securities Laws. ECF 85. On December 16, 10 2019, Defendants moved to dismiss that complaint. ECF 91. On June 2, 2020, the Court issued an Order granting in part and denying in part Defendants' motion to dismiss, and ordering the 11 transition of lead plaintiff from Rhode Island to Norfolk. ECF 110. On June 19, 2020, the Court issued an order appointing Norfolk as lead plaintiff and Robbins Geller Rudman & Dowd LLP 12 ("Robbins Geller") as lead counsel. ECF 113. On June 23, 2020, Norfolk filed its Revised Consolidated Class Action Complaint for Violation of the Federal Securities Laws (the 13 "Complaint"). ECF 114. The Complaint alleged, *inter alia*, that on November 1, 2018, Defendants made materially false and misleading statements and omissions about demand for the newly-14 released iPhone and Apple's business in China, in violation of §§10(b) and 20(a) of the Securities Exchange Act of 1934. The Complaint further alleged that the false and misleading statements 15 and omissions caused Apple stock to trade at artificially inflated prices and that, when the true facts were disclosed, Apple's stock price declined. 16

- 17 Defendants moved to dismiss the Complaint on July 13, 2020. ECF 118. Norfolk opposed the motion on July 27, 2020. ECF 120. On November 4, 2020, the Court issued an Order granting in part and denying in part Defendants' motion to dismiss. ECF 123.
 - On May 5, 2021, Norfolk filed its motion for class certification. ECF 165. On February
 4, 2022, the Court issued an Order granting the motion in part, certifying a Class of purchasers or
 acquirers of Apple common stock, and denying (without prejudice) the motion with respect to the
 proposed class of Apple options investors. ECF 224. The Court appointed Norfolk as the Class
 Representative, and Robbins Geller as Class Counsel. On April 15, 2022, Norfolk filed a
 supplemental motion seeking certification of a class of options investors. ECF 239. On March
 28, 2023, the Court issued an Order Modifying Class, which granted Norfolk's motion to certify
 call option buyers and put option sellers as part of the Class. ECF 352.

On September 9, 2022, Defendants filed a Motion for Summary Judgment and Motion to Exclude Expert Testimony. ECF 292, 293. On September 9, 2022, Lead Plaintiff filed an Omnibus Motion to Exclude Opinion Testimony of Defendants' Proposed Experts. ECF 301. On June 26, 2023, the Court issued an Order Denying Summary Judgment. ECF 369. On July 17, 2023, the Court issued an Order denying Defendants' Motion to Exclude and granting in part and denying in part Lead Plaintiff's Motion to Exclude. ECF 384.

1 instructions, and other pretrial materials, as well as setting a trial date of September 9, 2024. ECF 420.

In late 2021, the Parties first engaged the services of the Hon. Layn R. Phillips (Ret.), a nationally recognized mediator, to facilitate settlement negotiations. On January 31, 2022, the Parties attended a mediation session with Judge Phillips held remotely via videoconference. The January 31, 2022 mediation session was preceded by the submission of voluminous mediation statements including exhibits. The mediation did not result in a settlement.

⁵On May 25, 2022, the Parties attended a second mediation session with Judge Phillips, this time in person. The May 25, 2022 mediation was also preceded by the submission of supplemental mediation statements with additional exhibits and excerpts of deposition testimony by each of the Parties. Again, the Parties did not reach an agreement at that mediation and litigation continued.

Following the May 25, 2022 mediation and concurrent with the ongoing litigation, Judge 8 Phillips continued to correspond with the parties to explore the potential for resolution of the case. On January 10, 2024, the Parties engaged in another in-person mediation session with Judge 9 Phillips, but again the Parties were unable to reach a settlement. On February 14, 2024, Judge Phillips issued a mediator's proposal to resolve all claims alleged in the Complaint and on March 10 1, 2024 the Parties accepted the mediator's proposal. The agreement to accept the mediator's proposal included, among other things, the Settling Parties' agreement to settle and release all 11 claims that were asserted or could have been asserted in the Action in return for a cash payment of \$490,000,000 to be paid by Apple and/or its insurers on behalf of Defendants, for the benefit of 12 the Class, subject to the negotiation of the terms of a Stipulation of Settlement and approval by the Court. The Stipulation (together with the Exhibits thereto) reflects the final and binding agreement 13 between the Settling Parties.

Why is there a settlement?

The Court has not decided in favor of Defendants or the Lead Plaintiff. Instead, both sides agreed to the Settlement to avoid the distraction, costs, and risks of continuing the Action, and Lead Plaintiff agreed to the Settlement in order to ensure that Class Members will receive compensation.

The Plan of Allocation was developed in consultation with Lead Plaintiff's damages expert. In developing the Plan of Allocation, Lead Plaintiff's damages expert calculated the estimated 3 amount of alleged artificial inflation in the prices of each of the Apple securities that was allegedly proximately caused by Defendants' alleged materially false and misleading statements and 4 omissions the Court previously found to be actionable. In calculating the estimated impact allegedly caused by those misrepresentations and omissions, Lead Plaintiff's damages expert 5 considered the price changes in Apple securities in reaction to the public disclosures that allegedly corrected the alleged misrepresentations or omissions, adjusting the price change for factors that 6 were attributable to market or industry forces.

7 In order to have recoverable damages under the federal securities laws, disclosures relating to the alleged misrepresentations and/or omissions must be a cause of the decline in the price of 8 the security. In this Action, Lead Plaintiff alleges that corrective information allegedly impacting the price of Apple securities and determined to result in potentially recoverable damages (the 9 "corrective disclosure") was released to the market on November 5, 2018, November 12, 2018 and January 2, 2019 (after the close of trading). With respect to the November 5, 2018 and November 10 12, 2018 stock price declines, the Plan of Allocation reflects a 25% and 75% reduction, respectively, for litigation risk. 11

In order to have a "Recognized Loss Amount" under the Plan of Allocation, Apple common 12 stock or call options on Apple common stock must have been purchased or acquired during the Class Period and held through the issuance of at least one corrective disclosure. Put options on 13 Apple common stock must have been written (sold) during the Class Period and held through at least one corrective disclosure.

As detailed below, the Net Settlement Fund will be allocated on a *pro rata* basis according 15 to Recognized Claims for Class Member damages. The Net Settlement Fund will be allocated to Authorized Claimants as follows: (a) at least 96% of the Net Settlement Fund will be allocated 16 collectively to Apple common stock; and (b) no more than 4% of the Net Settlement Fund will be allocated to options on Apple common stock. 17



The notice provided was the best notice 18 practicable under the circumstances of those proceedings and of the matters set forth therein, 19 including the proposed Settlement set forth in the Stipulation, to all Persons entitled to such notice, 20and said notice fully satisfied the requirements of Federal Rule of Civil Procedure 23, due process, 21 and any other applicable law, including the Private Securities Litigation Reform Act of 1995. No 22 Class Member is relieved from the terms of the Settlement, including the releases provided for 23 therein, based upon the contention or proof that such Class Member failed to receive actual or 24 25 adequate notice. 10 Neither this Judgment, the Stipulation nor the Settlement contained therein, nor any 12. 11 act performed or document executed pursuant to or in furtherance of the Stipulation or the 12 Settlement: (a) is or may be deemed to be or may be used as an admission of, or evidence of, the 13 validity of any Released Claim or of any wrongdoing or liability of the Released Defendant Parties; 14 or (b) is or may be deemed to be or may be used as an admission of, or evidence of, any fault or 15 omission of any of the Released Defendant Parties; or (c) is or may be deemed to be or may be 16 17 used as an admission or evidence that any claims asserted by Lead Plaintiff were not valid or that 18 the amount recoverable was not greater than the Settlement Amount in any civil, criminal, or 19 administrative proceeding in any court, administrative agency, or other tribunal. The Released 20Defendant Parties may file the Stipulation and/or this Judgment in any other action that may be 21 brought against them in order to support a defense or counterclaim based on principles of res 22 judicata, collateral estoppel, release, good faith settlement, judgment bar or reduction, or any other 23 theory of claim preclusion or issue preclusion or similar defense or counterclaim. 24

13. The Court finds that Defendants have satisfied their financial obligation under the
Stipulation by paying or causing to be paid \$490,000,000 to the Settlement Fund, in accordance
with ¶2.1 of the Stipulation.
